## **TECHNICAL**

This garment has been designed to give a specified level of protection against accidental contact with blades and similar sharp implements. 

#### USE.

Each pair of cuffs consists of left and right handed units. **Each cuff should be fastened with the narrower, hook velcro strip outermost as illustrated.** The cuff should be fastened firmly around the wrist and lower arm so that it is not able to ride up the arm and expose the wrist to hazards.



#### **GARMENT CARE.**

New and used garments should be thoroughly inspected, especially after cleaning, to ensure no damage is present. Stored garments should be kept in a dry place away from heat and direct sunlight. Clean with a damp sponge when required. This garment can be disposed of/recycled in the same way as normal textile fabrics/garments
