

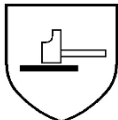

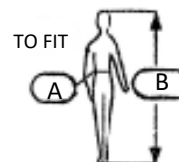
### CHIEFTAIN GARMENTS PG1/B JOGGING BOTTOMS & PG1/D BOXER SHORTS.

Please note – Kevlar® materials used in the garment change colour with continued exposure to light from bright yellow when new to a brownish colour. This does not affect the cut resistant properties of the garment.

**GARMENT CARE:** Stored garments should be kept in their original packaging in a dry place away from heat and direct sunlight. The fabric from which your Chieftain garment is made contains materials that are sensitive to temperatures above 100°C. **Do not let the garment come into contact with flame or very hot surfaces.**

New and used garments should be thoroughly inspected, especially after washing, to ensure no damage is present. Do not fill the washing machine more than 2/3 full.

**Do not use bleaches or caustic washing agents as these will damage the Kevlar® fibres.** Hand or machine wash in water not exceeding 40°C using a good proprietary washing powder or detergent, with low or no optical whitener and oxidant content, such as Dreft Automatic, Wisk or similar. **Do not dry clean.** Line dry or dry flat. **Do not tumble dry. Do not iron.**

Failure to observe the above instructions and aggressive or repeated washing may affect the mechanical or EN388 performance of the garment.

**REPAIR:** Do not repair this garment using fabrics other than fabrics of similar construction and blade cut resistant properties. If in doubt, consult the manufacturer before attempting repair.
