

TECHNICAL

This garment has been designed to give a specified level of protection against accidental contact with blades and similar sharp implements. In the design of this garment due respect has been paid to the basic health and safety requirements laid out in PPE Regulation (EU) 2016/425 as brought into UK Law and amended. The garment has been tested in accordance with EN 388: 2016.






Sizes - Waist 30" to 48" in 2" increments. Length - short 29", regular 31", long 33".

WHERE THERE IS ANY RISK OF CUTS TO THE INSIDE OF THE LEG THE GARMENT MUST BE WORN IN CONJUNCTION WITH A SUITABLE CUT RESISTANT APRON SUCH AS DALE TECHNICHE'S STYLE PG2/A. A SUITABLE APRON MUST BE WORN IN CONJUNCTION WITH STYLE PG3/B TROUSERS WHERE THERE IS ANY RISK TO THE UPPER LEG.

GARMENT CARE.

The test results for the garment were achieved after 5 washes. Stored garments should be kept in their original packaging in a dry place away from heat and direct sunlight. Hand or machine wash in water not exceeding 40°C using a good proprietary washing powder or detergent. **Do not use bleach**, Line dry or dry flat. **Do not tumble dry**. The garment can be ironed with a medium iron if necessary. Failure to observe the above instructions and aggressive or repeated washing may affect the mechanical or EN388 performance of the garment.

REPAIR. Do not repair this garment.
